#### **BREAKDOWN**

27/11/2022 (Sun)

From 4.30pm UNTIL 8pm - No exhibitors are permitted to stay on site overnight on Sunday 27<sup>th</sup> November.

**PLEASE NOTE**: You are <u>NOT</u> permitted to start packing down until after 4pm on the final day of the show. The venue has the right to demand that the show is closed as soon as exhibitors start breaking down as it breaks Health & Safety requirements (and stallholder refunds will not be given). Please do not put us in that position!

# **Marquee Exhibitors**

- Depending on the weather conditions, it is possible for condensation to form on the inside of the marquee roof, which may lead to water dripping as the marquee heats up\*. The dripping usually stops once the marquee has heated.
- Exhibitors should always cover their stand overnight with a
  waterproof covering and we strongly recommend that if you sell
  goods that can be damaged by water, you do not exhibit in the
  marquee.
- Although we use event blow heaters in the marquee\*, it is recommended that you bring suitable warm clothing, as temperature can drop when doors are left open for longer periods of time.
  - \*please note that the recently added second shopping marquee does not have heating

## Covid-19 Health & Safety Measures

Currently there are no Covid-19 restrictions governing this event, however we strongly recommend that you keep up-to-date with latest guidelines. **CLICK HERE** for full details on the government's website.

- Please do not attend show if you feel unwell or have Covid-19.
- It is good practice to wear PPE when serving customers (gloves etc).
- All exhibitors should keep their hands clean.
- Traders are expected to keep their stall safe and clean.
- Electronic payment methods (ideally contactless) should be used where possible.
- Sneeze guards are required for food products (if applicable).

#### **Site Access**

- Access to the site is permitted from 10am on Thursday 24<sup>th</sup> November.
- Please report to security on arrival.
- Opening times to public from 9am 4pm Friday, Saturday, and Sunday. If you are NOT on your stall & ready by 8:45am on the first day of the show, for whatever reason, you will be refused entry, and no refund will be given.
- Access onto site during event opening times is not permitted.
- Access onto site during times event closed i.e. nighttime via main entrance (see security).

## Stand Space Booked & Exclusivity

- Please ensure that you have booked adequate space for your stand...
- The size you have booked includes access to your stand there is no extra space between traders for access or egress. Please ensure that you take this into account when setting up your stall.
- If you require additional space (at extra charge), please contact us on 01702 549623 for availability prior to the event set-up dates.
- Exhibitors must keep within the space booked any goods or tables that are outside the booked space will have to be removed.
- Exhibitors are only permitted to display & sell items detailed on the booking form (unless authorised by Aztec PRIOR to the show).
   Aztec has the right to ask unauthorised products to be removed.
- We do not guarantee exclusivity to any exhibitor.
- Outside space is set on hard-standing (gravel) sufficient weights must be used to secure marquees. Under NO CIRCUMSTANCES must stakes be used to secure marquees.

## **Power Access & Table Supply**

- Power is ONLY provided to stands if booked prior to the show.
- We strongly recommend you use low wattage halogen bulbs or standard lighting.
- Electrical equipment must be PAT tested.
- Please bring your own PAT tested extension lead if required. We do not provide extension leads.
- Kettles or heaters are NOT permitted.

- Aztec Shows will not be held responsible for any loss of power.
- You will not receive tables unless pre-booked. Additional tables can be pre-booked at a cost of £10.00 (+vat). Please ensure that you keep your table clean.
- Please check on arrival that tables provided are correctly and safely opened - Aztec are not liable for damage or breakage of any items. No extra tables will be available on the day of the show.

## **Exhibitor Parking**

- Once unloaded exhibitors can park vehicles in the exhibitor
  parking area (stewards will direct), which is located on grass area
  behind the catering area.
- Dependent on ground conditions, exhibitors in the external marquees may park behind. In the case that the ground is deemed unusable the exhibitor parking area must be used.
- No driving is permitted on site during show opening hours

#### **Stall Presentation & Trading Standards Regulations**

- THIS IS A FESTIVE SHOPPING EVENT so please dress your space accordingly.
- Aztec Shows reserve the right to ask exhibitors to remove any goods considered unsuitable.
- All stalls must be presented to 'high' (and professional) standards as expected at a quality event. TABLECLOTHS / COVERINGS MUST BE USED and where possible must reach the floor.
- To comply with Trading Standard regulations, all exhibitors must ensure that all goods are clearly priced.

# Insurance / Licenses/ Risk Assessments

 All exhibitors must have their own public liability insurance present at the event. Where relevant, exhibitors are required to have to hand (at show) all necessary licences / insurances including <u>personal licence</u> if alcohol is being sold.

**IMPORTANT** – the personal licence holder MUST be on site overseeing the sale of alcohol. It is not possible for a personal licence holder who is not on site to designate to a staff member at the event.

- Exhibitors are responsible for every object displayed by them on their stand including liability of all claims arising from handling of objects.
- Risk assessments must be completed and should be available to view on request at the event.
- Exhibitors shall indemnify Aztec Shows against all claims, damages or expenses arising from any incident, that may occur at the show.

# **Public Safety**

- Any exhibitor that does not adhere to any Covid safety measures may be asked to leave the event.
- All exhibitors must not pack away until after the published closing time as stated by Aztec Shows.
- Exhibitors must not place goods or tables of any kind in public walkways. Vehicles, boxes or trolleys must not be moved on site whilst the fair is open to the public.
- Exhibitors are responsible for the safety of their stand please see note on Insurance.

## **Behaviour**

- Violence or threatening behaviour towards any member of the Aztec Shows team or members of the general public or other exhibitors will not be tolerated.
- Failure to comply will result in immediate expulsion from the event and the appropriate authorities will be notified. No refunds will be given.
